DEAR PRINCE GEORGE'S COUNTY COMMUNITY,

As I reflect on our work over the past year, I am reminded of the many milestones that we collectively achieved. It has been a phenomenal year here at the Greater Washington Community Foundation – a time of both personal and professional development, community challenges and opportunities, and organizational change and growth.

I am proud to share our FY23 Impact Report with you. The report showcases our efforts over the past year and the partnerships that have made our success possible. I want to invite you to look back with me for a moment. This year, the Prince George's County office:

- Celebrated 25 YEARS OF SERVICE!
- Awarded grants of \$1.7 MILLION in FY23 to 100+ nonprofit organizations in Prince George's County for a total of \$65 million in grants since our inception in 1998.
- Relaunched the PARTNERSHIP FOR PRINCE GEORGE'S COUNTY which brings together
 philanthropic leaders from throughout the region to increase philanthropic capital and
 address economic justice.
- Formed a NEW PHILANTHROPIC PARTNERSHIP WITH THE MEYER FOUNDATION with the
 intent to launch a two-year Guaranteed Income Pilot project. The program will provide a
 monthly cash payment to individuals to improve their prospects for economic mobility
 and overall well-being.
- Worked with **ENTERPRISE COMMUNITY PARTNERS' FAITH-BASED INITIATIVE** to support efforts to build the capacity of faith-based CDCs to lead community economic development projects in the county's most economically marginalized neighborhoods.
- Formed a NEW PARTNERSHIP WITH PRINCE GEORGE'S COUNTY PUBLIC SCHOOLS
 (PGCPS) to launch a Youth Opportunity Fund pilot program. Students from kindergarten
 through graduation from high school will amass a financial nest egg that offer critically
 needed pathways to economic mobility and can close the racial wealth gap when deployed
 in equitable ways.
- Engaged in conversation and collaboration with the county's faith community, over the past year, to improve the lives of residents by working together to close the racial wealth gap as part of our new FAITH AND PHILANTHROPY PROJECT.

A heartfelt thank you to all of our donors, partners, County Government, and corporations. Your deep commitment, generous support, and the trust you placed in The Community Foundation nearly 25 years ago has made our transformative work possible.

Together, we've accomplished a lot, but there is still so much more for us to do. As we continue to move forward, I ask you to Imagine with me all of the possibilities that the next twenty-five years can bring.

We look forward to 25 more years of partnering with you!

COVID-19 EMERGENCY RESPONSE FUND a coordinated philanthropic effort to address the urgent health and economic needs of people across the region who were disproportionately impacted by the pandemic. This effort continues to meet evolving needs and challenges, while also working toward an equitable recovery from this public health emergency.

DOMESTICVIOLENCE COMMUNITY ASSISTANCE FUND awards grants to assist individuals, families, and survivors of domestic violence in achieving a greater level of independence, strengthen the family's ability to cope with healing, and rebuild the family unit by removing various challenges which inhibit self-sufficiency, including legal services, counseling services, support groups, employment, training, and housing.

EMERGING LEADERS IMPACT FUND encourages collective giving and civic engagement. Young professionals participate in a giving circle to pool their philanthropic resources, learn first-hand about nonprofits working in Prince George's County, and invest in organizations that help residents participate more fully in the social and economic growth of the county.

FUND FOR GREATER WASHINGTON ensures that The Community Foundation can build a thriving region where every person prospers by targeting urgent and emerging needs through advocacy, research, community engagement, and strategic investments, while pursuing long-term change to disrupt intractable inequities.

SHARING PRINCE GEORGE'S brings donors together to invest in high-impact nonprofits working to achieve our shared vision of a more equitable, just, and thriving Prince George's County by addressing urgent community needs, advancing economic justice, and, ultimately, working to close the racial wealth gap which undermines the health and stability of our entire community.



NONPROFIT SPOTLIGHT

COURT APPOINTED SPECIAL ADVOCATE PRINCE GEORGE'S COUNTY (CASA) advocates for the rights, needs, and timely placement of children living in foster care in safe, loving, and permanent homes. CASA trains and supports volunteers to serve as caring adults to help improve the lives of children. Funding supported CASA's ability to partner with the juvenile court to promote the timely placement of children living in foster care.

COMMUNITY CRISIS SERVICES (CSS) provides compassionate crisis support through its hotline, safe-shelter programs, and information and referral services. CSS operates 24-hours a day, 365 days a year for anyone facing crisis and personal turmoil. Funding provided rental assistance to victims of domestic violence.

A donor-driven initiative, Sharing Prince George's has spent the past year meeting with nonprofit organizations across the county. In alignment with The Community Foundation's Strategic Vision, the group met primarily with organizations focused on the three key intervention areas to help close the racial wealth gap — Basic Needs, Economic Mobility, and Individual and Community Wealth Building. This year's nonprofit partners provide a diverse range of services to the Prince George's community — from housing rehabilitation and workforce development to promoting the arts and environmental efforts.

Making Moves provides technical training while developing students' confidence, poise, and self-esteem. Grant funds helped ensure the participation of Prince George's area youth.

JOE'S MOVEMENT acts as a catalyst for creativity and economic opportunity in Mount Rainier, Maryland. Joe's five arts-based youth programs help bridge the creative divide between under-resourced families and those with means through programs and productions in education, performing arts, and work readiness. The grant provided critically needed operating support for programs that encourage the development of resilience and ingenuity, as well as the critical-thinking, collaboration, and problem-solving skills young participants need for a successful future.
