



David Bradt Nonprofit Education Award Pre-Vetted Leadership Programs

David Bradt Nonprofit Education Fund at the Greater Washington Community Foundation will provide an annual award for a nonprofit leader in the Greater Washington region to attend an intensive executive training program. The steering committee is particularly interested in helping leaders attend programs which will enhance their leadership, creative thinking, strategy, and management skills. They also will prioritize cohort programs which will enable leaders to expand their professional networks while also deepening their knowledge and skills.

The following is a suggested list of executive leadership programs that have been screened by the selection committee. Please note that the committee may consider other leadership programs on a case-by-case basis, taking into account the goals of the awardee, strength of the program, etc.

Center for Creative Leadership's Leadership Development Program www.ccl.org

An intensive, five-day program designed for leaders of managers (managers in the middle). It is built around 6 factors vital to the success of managers: influence, communication, thinking and acting systemically, self-awareness, resiliency, and learning agility. The three-phased approach assesses participant's current leadership skills, engages participants in real-world leadership scenarios, and assess participant's progress once the program has been completed.

A nine-month, twelve credit (four course) program that provides skills and experiences that will allow participants to delve deeply into the complex challenges facing nonprofit leaders in the U.S. and abroad. The Graduate Certificate in Nonprofit Management and Leadership equips students with the capability to formulate innovative strategies to negotiate the complexities of philanthropy and nonprofit leadership. Coursework in the Certificate can be used toward a master's degree should participants decide to continue their studies.
